**IV. General Class Contractor License Applications**

Bert West explained the Board of Review process to the contractors in the room. They will be called on to give their full name, company name, the reasons for requesting a contractor license in Teller County, and the type of license for which they are applying.

**A. Rilo Enterprises LLC, dba Colorado Shed Company, Richard Lauer, Class A**

Richard Lauer introduced himself and stated that he is from Virginia and purchased the company in 2023. He has worked in construction the last 12 years. They build agricultural buildings such as pole barns, horse barns, and detached garages. They do not build residential buildings. They are seeking a license in Teller County because of the opportunity to build a pole barn.

Bert West inquired as to why a General Class A license was being applied for. Mr. Lauer stated that the previous owner advised him to apply for the Class A license.

Building Official report and recommendation: Applicant currently holds a provisional B-E license with Pikes Peak Regional to construct non-habitable accessory structures for single-family residences and has passed the National Building Contractor C Exam. Building Division recommends a C license.

**B. All Phase Restoration Colorado Springs, LLC, Lucas Craig, Class B**

The Building Official informed the Board that All Phase Restoration requested to be placed onto the April meeting agenda. Mr. West agreed to reschedule this to the April meeting.

**C. Dreamstyle Remodeling of Colorado LLC., Clinton May, Class C**

Clinton May introduced himself and then informed the Board that he had started in Tennessee as a licensed contractor flipping and remodeling homes. He worked for Regency Home Builders for a year and a half and then became the Regional Operations Manager for Sears Home Improvement, managing remodels for the western half of the United States. He passed the ICC exam and is licensed in Kansas and in most of the municipalities in Colorado. He is currently the General Manager for Wood Bridge Home Solutions which does home remodeling as well as being employed with Dreamstyle Remodeling of Colorado.

Bert West noted the references only mention windows, siding and doors for the construction experience, so he recommends a C-1 license. The applicant agreed with this change to a C-1 license.

Building Official report and recommendation: Applicant has experience in single family residential windows and siding replacement. He passed ICC National Standard Building Contactor A exam but with limited references and scope of work, the Building Division supports the C-1 license.
