1. 9:20 a.m. Convene in Regular Session:

The Board of County Commissioners of Teller County convened in regular session in the Teller County Centennial Building in Cripple Creek, CO.

Mr. Campbell presided.

Mr. Williams gave the invocation.

Mr. Jay Teague led the Pledge of Allegiance.

Minutes of Previous Meetings:

Action: Mr. Williams moved, and Mr. Stone seconded, to **approve** the minutes of the meeting of the Teller County Board of County Commissioners on April 9, 2024, as presented. All Commissioners voted yes.

Accounts Payable:

Action: Mr. Stone moved, and Mr. Williams seconded, that the Board **approve** the accounts payable run date of April 18, 2024, in the amount of \$639,499.37. All Commissioners voted yes.

Board Reports:

Mr. Stone:

- Gave update on the final weeks of legislative session.
- Opposes House Bill 24-1460 on law enforcement misconduct reporting requirements. Sheriff Mikesell is testifying today in opposition.
- Attended the Senior Coalition Expo event in Woodland Park last weekend.
- Glad to see that fire mitigation is occurring in the community. This is the time of year to mitigate your property.
- Attended meetings with Pikes Peak Area Council of Governments (PPACG), including a transit meeting for Cripple Creek and Teller County Senior Coalition.

Mr. Williams:

- Attended Senior Coalition Event and commented on the decrease in their funding. Recognized Teller County Public Health and Department of Social Services for



their attendance at this event.

- Attended the Colorado Sportsmen's Caucus Day at the Capitol in Denver. This was a bipartisan event to educate legislators and the public about hunting and fishing traditions; commented the urban/rural divide in the state.
- Provided an update on the progress being made with the Department of Natural Resources (DNR) on preserving future water rights.
- Attended a Colorado Counties, Inc. (CCI) session on Thursday.
 - He is focused on bills regarding land use and clean energy.
 - The bill on Accessory Dwelling Units (ADU) will only apply to areas with a population of more than 40,000 so it will not affect Teller County.
 - There are multiple gun bills and the conceal carry bill goes to the Governor today.

Mr. Campbell:

- Attended a 4H event last Saturday and judged the smoked meats and BBQ contest.
- Attended the Community Partnership Summerfest event and it was well-attended.
- The Crabby Tax Night with the Kiwanis was successful.
- Gave update of the ongoing audit of the Pikes Peak Workforce Center (PPWC).
- He is tracking 18 Tax and Finance related bills. HCR 24-1006 was introduced to submit a property tax bill to the voters in November to amend the Constitution for TABOR rates plus 2% growth on property tax values.

Elected Officials Report: (None)

Administrator's Report:

Ross Herzog, County Administrator

- Teller County Sheriff's office is fully staffed.
- Public Works has openings for equipment operators.
- Road crews continue to work on repairs focusing on potholes.
- Teller County Wastewater Utilities (TCWU) was awarded a one million dollar grant from the Department of Local Affairs (DOLA) for its upgrade and expansion project.

Commissioner Campbell commented on the extensive work Public Works is doing to repair the roads.

Commissioner Williams shared he had positive feedback from two Home Owners Associations in the county.

Jay Teague, Director, Office of Emergency Management

- Preparing for 2024 fire season. Working with the Fire Chiefs in the region to confirm fire resources.



- Introduced Shane Pratt, CERT Program Manager for Teller County, who described the CERT program.
 - FEMA based program.
 - Basic class is 20 hours.
 - 35 students have completed the course.
 - 17 students for tonight's class.
 - 5 people have been certified to date.

The Board thanked Mr. Pratt and commented on the CERT program.

Commissioner Stone commented on the one-million-dollar grant from the Colorado Strategic Wildfire Action Program (COSWAP) for fire mitigation and coordination with OEM to match.

 - b. The Teller County Mental Health Alliance is pursuing grants.

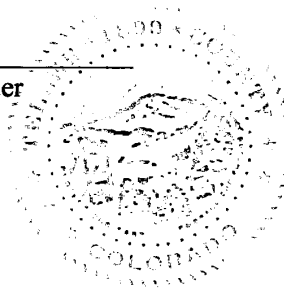

RESOLUTION NO. 04-23-2024 (13)

A RESOLUTION TO AMEND THE 2024 GENERAL, ROAD AND BRIDGE, JAIL ENTERPRISE, FLEET MANAGEMENT, AND DSS FUND BUDGETS.

WHEREAS, in the past, the County has recognized significant savings from employment turnover that the Board of County Commissioners could consider for use in other areas; and

WHEREAS, the Board of County Commissioners has directed staff to make a monthly budget adjustment by transferring personnel related funds from individual departments to holding departments within each fund as personnel budget needs are reduced; and from holding departments to individual departments as personnel budget needs increase, within county policy; and

WHEREAS, funds budgeted in the above referenced holding departments, which have been added to each fund as Personnel Contingency Departments (ending in the numbers 2190), are not appropriated nor available for expenditure and are only accessible by resolution of the Board of County Commissioners transferring them to other departmental budget accounts; and

WHEREAS, the Board of County Commissioners hereby finds, determines and declares that adoption of this Resolution is necessary for the preservation and protection of the public health, safety and welfare of the inhabitants of Teller County, Colorado,

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TELLER COUNTY, COLORADO:

that the departmental budgets and Personnel Contingency Department accounts be decreased as follows:

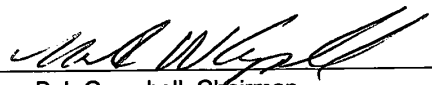
