**A RESOLUTION RESCINDING THE STAGE I FIRE BAN RESTRICTING OPEN
BURNING IN TELLER COUNTY, COLORADO.**

WHEREAS, the conditions throughout the region that left Teller County in a very vulnerable condition for wildfires have been lessened by recent moisture so that extreme fire hazard conditions no longer exist throughout Teller County; and

WHEREAS, the Sheriff as the Fire Warden of Teller County, Colorado has requested that certain restrictions on open burning in the unincorporated areas of Teller County be rescinded; and

WHEREAS, this Resolution is intended to rescind and repeal the current Stage I Fire Ban implemented pursuant to Teller County Resolution Number 07-31-2024 (25) and Ordinance #17; and

WHEREAS, the Board of County Commissioners hereby finds, determines, and declares that the adoption of this Resolution is necessary to preserve and protect the public health, safety, and welfare of the inhabitants of Teller County.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Teller County, Colorado, by virtue of the authority vested in the Board by the laws and Constitution of Colorado, including specifically C.R.S. 30-15-401(1)(n.5), that the Stage I Fire Ban implemented by Resolution Number 07-31-2024 (25) is rescinded and repealed effective at 12:01 p.m. August 13, 2024.
