WHEREAS, the Board of County Commissioners has determined that the Teller County Roadway Design and Construction Standards adequate infrastructure requirements should be amended to more appropriately address impacts created from divisions of land into parcels of 35 acres or more to existing roads dedicated to public use and within unincorporated Teller County; and

WHEREAS, the Board of County Commissioners hereby finds, determines and declares that adoption of this Resolution is necessary for the preservation and protection of the public health, safety and welfare of the inhabitants of Teller County, Colorado.

NOW, THEREFORE, BE IT RESOLVED, that effective May 22, 2003 the following Amendment is hereby adopted and made part of the Teller County Roadway Design and Construction Standards.





A RESOLUTION IMPOSING A MORATORIUM ON THE ACCEPTANCE OR APPROVAL OF APPLICATIONS FOR BUILDING PERMITS AND CONDITIONAL USE PERMITS FOR MORE THAN ONE DWELLING AND/OR STRUCTURE USED FOR HUMAN HABITATION ON CERTAIN PARCELS.

WHEREAS, the current Teller County Land Use Regulations allow, on some parcels, either as a Permitted Use or a Conditional Use, more than one dwelling and/or structure used for human habitation; and

WHEREAS, the impacts of such use on road and other infrastructure, and on an adequate and safe water supply, are of concern to the residents and businesses in Teller County; and

WHEREAS, the Board of County Commissioners of Teller County has requested that staff review and propose amendments to the Land Use Regulations (including but not limited to Section DE-20-3 Density and Parcel Size – Zoning District Standards, Section DE-20-5 Dual Zoning, Table 1: Uses and Zones, Section AC-20 Accessory Use or Structure, and Section GU-60 Guest House) regarding such multiple dwellings and/or structures used for human habitation on certain parcels; and

WHEREAS, Teller County is authorized by Colorado Statutes to establish regulations regarding land use within the unincorporated area of Teller County; and

WHEREAS, the Board of County Commissioners determines that a period of time extending to September 19, 2003, will be required to study this matter, prepare draft amended regulations, conduct hearings, and adopt such amended regulations; and

WHEREAS, the Board of County Commissioners determines that the status quo (allowing only one dwelling and/or structure used for human habitation on parcels created after the date of this Resolution) should be maintained pending the adoption of such amended regulations; and


WHEREAS, the Board of County Commissioners hereby finds, determines and declares that adoption of this Resolution is necessary for the preservation and protection of the public health, safety and welfare of the inhabitants of Teller County, Colorado.

NOW, THEREFORE, BE IT RESOLVED by the County Commissioners of Teller County, Colorado that a moratorium be, and it is hereby, imposed on the acceptance or approval of applications for building permits and conditional use permits which would allow for more than one dwelling and/or structure used for human habitation on parcels created on or after May 22, 2003, in all zones, which moratorium shall take effect immediately and shall extend to 11:59 p.m. on the 19th day of September, 2003, or the adoption and enactment of regulations concerning this issue, whichever occurs first. The following shall be exempt from this moratorium:


1. Any parcel legally created prior to May 22, 2003.
2. Applications for building permits for duplex or multi-family dwelling structures.
3. Building permits and conditional use permits for dwellings and/or structures used for human habitation approved prior to the date of this Resolution.




